CAP Expansion

- Funded through Race To The Top/Early Learning Challenge Grant (RTT/ELC) application
- 3 Subject areas identified by CDD:
 - Administration
 - Infant/Toddler
 - Children With Special Needs
- These are additional courses to help meet the needs of the workforce and to meet the Competencies.
- Project period Aug 1, 2012 Dec. 31, 2015

Comparison

Original CAP 8

- Align as a package.
- Included in a degree.
- course components.
- Submit all 8 courses and degree at same time.

CAP Expansion

- Aligned individually.
- Not required to be in a degree.
- Contain, but not limited to, all Contain, but not limited to, all course components.
 - Submit courses 1 at a time or in a



CAP Expansion Notes

- The CAP Expansion courses DO NOT replace the original 8 CAP courses.
- Colleges must be CAP aligned before submitting any Expansion courses.
- There is no requirement for colleges to have or develop all CAP Expansion courses.
- Prerequisites will not be addressed as part of CAP Expansion.

CAP Expansion Notes

- There is no requirement for colleges to offer Expansion courses every semester.
- Inclusion of a lab component is at the discretion of an individual college.
- For alignment, campuses will be required to include, but are not limited to, all of the components from the Expansion templates (i.e., title, description, content, objectives).

CAP Expansion Tasks

- Identify which courses are currently taught at CA Community Colleges (completed in Fall 2012)
- Decide on which specific courses for each of the 3 areas.
 - Input on these courses was collected during the Fall 2012 CCCECE Regional Meetings



CAP Expansion Tasks

- Gather input on course content from faculty and subject-area experts (Spring 2013)
- Draft preliminary templates for Expansion courses (Summer 2013)
- Post preliminary templates for review and vetting (Goal: Fall 2013)
- Post final templates (Goal: Spring 2014)
- Accept submissions for review and verification
 (2014)

Fall CCCECE Survey Results

84 faculty from CA Community Colleges submitted survey information on:

• Titles and content for the specific courses within each subject area.

Some general findings include:

Fall CCCECE Survey Results

The majority of faculty agreed:

- 3 courses in the Administrative subject area
 - A course covering policies, procedures and programs
 - A course covering supervision and management
 - A 3rd course covering Adult Supervision/Mentoring
 - Faculty (60 out of 69 that responded to this question) also agree with increasing the units for Adult Supervision (from 2 to 3).
 - A final decision has not yet been made on the unit value of this course; additional input will occur before outlines are completed.



Fall CCCECE Survey Results

2 courses in the Infant/Toddler subject area:

- A course covering infant toddler growth and development
- A course on infant toddler curriculum and group care

Note:

Inclusion of a lab component can be determined by individual campuses

2 courses in the Children with Special Needs subject area:

- A course covering young children with special needs,
- A course covering strategies/curriculum for young children with special needs.

 - Prioritize the content for each specific course.



Regional Meeting Tasks

- A strategy to keep your content list manageable is to use broad topic headings with sub-categories.
 - For example:
 - Regulations (a main topic)
 A. Title 22 (sub-categories)

 B. Title 5
